

BDcoin - Terms of Use

Following are the terms of use for BDcoin website which you agree to when accessing and using the website. These terms may be changed, updated or modified over time in accordance with the updated laws and regulations at the sole discretion of our Company. Make sure that you read and understand all these terms carefully. Please do not use the website or any of the content available on the website if you do not agree to the terms mentioned here. Use of BDcoin Website
